

# **2025 redeemable activities**

|            | Activity   | Reward |

### **Terms and conditions**

Members can earn rewards by completing some or all program activities. Rewards can be earned from January 1 to December 31, 2025. Participation in the rewards program is voluntary and does not affect a member's Medicare Advantage plan benefits.



## **Frequently asked questions**

### What do you need to do?

Earn rewards in 3 simple steps:

- Complete eligible activities
- Self-report completion of activities using your preferred communication channel
- · Select a gift card of your choice

### How long does it take to get a reward?

Physical gift cards will be mailed to your home address in 2 to 6 weeks.

Choose a gift card from CVS Pharmacy<sup>®</sup>, The Home Depot, Starbucks, Subway and more. For a complete list of available gift cards, visit **<u>Aet.na/HealthyRewards</u>** and log in to your member portal.

### How many gift cards can you select?

You can choose to redeem after each activity completion (for example, 5 gift cards) or accumulate the max eligible amount for a single gift card. You can select gift cards in increments of \$5.

### How can you report and confirm completion of eligible activities to earn rewards?

There are 3 ways. You can:

- Log in to your member portal at
  <u>Aet.na/HealthyRewards</u>
- Return the prepaid business response card provided with your program materials.
- Call the number included in your program materials. You will need to provide a personalized code that is provided in the materials.

## Have questions about a gift card that you didn't get?

Check your personalized rewards center in the **Aet.na/HealthyRewards** member portal by clicking on the Rewards dashboard. Or click on the gift icon located on the top right-hand corner of the home page.

See Evidence of Coverage for a complete description of plan benefits, exclusions, limitations and conditions of coverage. Plan features and availability may vary by service area. Medicare rules don't allow earned rewards to be used for Medicare-covered goods or services, including medical or prescription drug out-of-pocket costs. Earned rewards may not be used to pay for medical copays, prescription costs, or any other Medicare covered good or services. Earned rewards may also not be used on alcohol, tobacco or firearms or be converted to cash.

Rewards earned may be considered taxable income. Please consult your tax adviser if you have any questions regarding the taxability of rewards.

The 2025 Aetna Healthy Rewards program is only applicable to active members with eligible MA and/or MAPD plans. Qualifying participants who are eligible to perform the program activities may earn rewards by completing all or some of the program activities. The 2025 Aetna Healthy Rewards program is available to our members until the last day of the year. You will need to earn and redeem your reward by December 31, 2025 or the date you leave the plan, whichever comes first. Participants should check the terms of their Evidence of Coverage (EOC) prior to participating in any program activities. Aetna shall not be responsible for any costs associated with, or arising from, a participant's performance of program activities. Your participation in Aetna Healthy Rewards program is voluntary and does not affect your benefits from your Aetna health plan.
